NOTE: Covid Protocols are still in place from last year; If you were an artisan in previous years and were not able to vend at the market last year, please still submit an application WITHOUT fee and we will put you on the wait list in hopes that we will be fully open by the end of July. Thanks.

Fees-- Please Choose One:

To save vending space fee is due April 30, 2021

\$250 per Full Season

Approximately a 20ft wide by 17ft deep space assigned to you for the season. (2 parking spaces). This is paid in advance at the beginning of the season. Example: space 17a **and** 17b.

\$125 per Full Season

Approximately a 10ft wide by 17ft deep space assigned to you for the season, 10' x 10' canopies **only** (1 parking space). This is paid in advance at the beginning of the season. Example: space 17a **or** 17b.

\$ 25 per Saturday

Approximately a 10ft wide by 17ft deep space assigned to you for the day, 10' x 10' canopies **only** (1 parking space) on a first come-first serve basis at the market. Please call the market manager in advance to check on availability.

\$375 per Full Season – this is for a 3 space vending area (30ft wide by 17ft deep)

Product List:

Please provide an (approximate) accounting of the products you intend to sell at the market this season. This information will help us to better advertise the market. Please refer to the Manistee Farmers Market guidelines regarding **the percentage of products that must be grown or produced by the vendor** selling them. In addition, ***if you are ‘reselling’ any product, please note on this sheet what it is and where it is from (business name and address), keeping in mind that you are allowed to resell from only one business other than your own for the entire market season.***
